1). About the Privacy Policy

The purpose of the Privacy Policy of Transport Rok Miklič d.o.o. (hereinafter: the "Privacy Policy") is to inform users (hereinafter also referred to as "individuals") about the purposes and legal bases for the processing of personal data by Transport Rok Miklič d.o.o., as well as about the rights of individuals in this area.

The company pays special attention to the security of your personal data. All personal data provided are treated confidentially and are used solely for the purpose for which they were provided. We manage your personal data with the utmost care, in accordance with applicable legislation and the highest standards of data protection. To ensure the security of your personal data, we implement appropriate organizational measures, work procedures, advanced technological solutions, and cooperate with external experts to ensure the most effective protection possible. We apply an appropriate level of protection and reasonable physical, electronic, and administrative measures to protect collected data against accidental or unlawful destruction, loss, alteration, unauthorized disclosure, or unauthorized access.

This Privacy Policy also further explains the consent you have given for the processing of your personal data.

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation – GDPR), this Privacy Policy includes the following information:

2). Personal Data Collected by the Company

If you are a visitor to the website, we collect data about you only through the use of cookies.

What are cookies?

A cookie is a file that stores website settings. Websites store cookies on users' devices to recognize individual devices and the settings used. Cookies allow websites to recognize whether a user has already visited the site and enable advanced applications to adjust individual settings accordingly. Cookie storage is fully controlled by the browser used by the user, who can restrict or disable cookies at any time.

Why are cookies necessary?

Cookies are essential for providing user-friendly online services. The most common e-commerce functions would not be possible without cookies. Cookies make interaction between the user and the website faster and easier. They allow websites to remember individual preferences and experiences, making browsing more efficient and pleasant. Cookies are used to store website state data, enable online services, collect statistics on users and website traffic, and analyze user habits. Through cookies, we can assess the effectiveness of our website design.
